2004-2008 RX-8 Rotary Engine Core Limited Warranty Extension Program SSP 77

Dear Mazda Owner:

Mazda Motor Corporation is conducting a Special Service Program (SSP) which extends the warranty coverage on Rotary Engine Core Components on all 2004, 2005, 2006, 2007 and 2008 model year RX-8 vehicles. The warranty coverage for the Rotary Engine Core Components will be extended to 8 years (96 months) from the original warranty start date, with a 100,000 mileage limitation. If you are a recipient of this notice, your vehicle is included in this program.

- Rotary Housing and Internal Parts
- Internal Seals and Gaskets

Included in this notification is an addendum card to be placed in your original Warranty Information Booklet and an RX-8 Product DVD. This DVD highlights some unique characteristics of your Mazda RX-8, as well as maintenance and driving tips.

This warranty extension is effective immediately and does not require a visit to your local Mazda dealer.

What if you have paid for a repair that is covered by this new warranty?

If you have paid for a repair out of warranty which would have been covered by this extended warranty, you may be eligible for reimbursement of reasonable repair expenses based on Mazda's repair standards.

Please complete the enclosed "Reimbursement Application Form," including the necessary documentation, and mail it to us in the pre-addressed envelope provided, allowing 6-8 weeks for processing.

If you have moved or no longer own your RX-8, please complete the enclosed prepaid *Information Change Card* as soon as possible. This enables us to update our records and notify the current owner.
