DESCRIPTION

Some customers may comment that most of their CD's (Music CD's particularly) do not display any text in some or all fields and is instead filled with horizontal lines ("------"). They may note when playing the same Music CD in their personal computer, information including Artist, Album and Song name is displayed.

On vehicles equipped with touch-screen navigation systems, when the system display is in CD Mode, the audio unit has the ability to display text from the audio CD being played (when information is available). The fields (e.g. DISC, TRACK, ARTIST...) of text that can be displayed will vary if the CD in question is a standard Music CD (e.g. store bought) or an MP3 CD.

On the vehicle, "-----" will be displayed in fields where textual information is not found on the CD. The presence of "------", does not indicate any concern in the vehicle's audio system.

MP3 CD's

For MP3 CD's, this condition is due to how MP3 files are generated, titled/labeled, and stored on the MP3 CD. There are a variety of software programs that can be used to generate an MP3 CD. To optimize the abilities of your MP3 CD, refer to the Instructions, Suggestions and/or Help of the respective program used to generate MP3 CD.

Music CD's

For standard Music CD's, this condition is due to the manufacturing standard of CD and not the vehicle's audio system. If the Music CD was not manufactured with the information embedded into it, it cannot be added to that CD.

NOTE:

• Some store bought Music CD's that have the information embedded in them will indicate by showing the label below, but this is often not the case.



Regarding information being displayed on a personal computer, many CD player software programs, when connected to the internet, are able to reference a database, and by matching the CD, will retrieve this information. Even if the computer is not still connected to the internet, if the data is retrieved once, it is often stored on the local hard drive for future use.

If the customer plans on using their CD's to create their own mix in the standard Music CD format, inform them some of the more recent software programs they could use have the ability to retrieve, add, and/or edit information and have it embedded into the CD when it's burned. These programs include Roxio and Realplayer. To optimize the abilities of adding and editing this information, refer to the Instructions, Suggestions and/or Help of the respective program used to generate the Music CD.
